See *Faretta v. California*, 422 U.S. 806, 834-35 (1975) (identifying factors for valid waiver of counsel); *Coleman*, 235 Ariz. at 198-99, ¶ 19 (requiring a "Faretta-like hearing" before accepting waiver of appellate counsel). FURTHER ORDERED: Directing the clerk of the superior court to transmit to this court a certified copy of the superior court's determination regarding appellant's waiver of appellate counsel within 5 days after its entry, marked for filing in this appeal. FURTHER ORDERED: That the stay will be automatically lifted on 08/27/2024, unless one of the parties or the superior court seeks to extend the stay.
