29. 26-Mar-2026 The Court has identified two malicious prosecution cases that may affect resolution of the petition for review: *Wisniski v. Ong*, 94 Ariz. 123 (1963), and *Creamer v. Raffety*, 145 Ariz. 34 (1984). These cases concluded that a criminal conviction, even if later reversed, "conclusively establishes the existence of probable cause, unless the conviction was obtained by fraud, perjury or other corrupt means." See *Wisniski*, 94 Ariz. at 124-25 (quoting Restatement of Torts § 667); *Creamer*, 145 Ariz. at 40, ¶129. Although the parties here addressed the effect of the juvenile removal and dependency adjudications, neither party cited *Wisniski* or *Creamer*. The Court is considering whether the principle announced in these cases applies to wrongful institution of civil proceedings claims. Therefore,

IT IS ORDERED the parties file simultaneous briefs on or before April 10, 2026, addressing whether the holdings in *Wisniski* and *Creamer* apply to the claims in this case. The briefing should not exceed 10 pages. No response briefs are permitted. (Hon James P Beene)
