IT IS FURTHER ORDERED that all protective orders entered by the superior court to protect victims' rights related to ROA 549, 559, 575, 593, and 595 shall remain in full force and effect subject to further order of this Court.

IT IS FURTHER ORDERED that the above order temporarily unsealing ROA 549, 559, 575, 593, and 595 to allow the Clerk of the Supreme Court to provide copies to counsel for the parties does not relieve counsel of their duties and obligations pursuant to the Arizona Victims' Bill of Rights, Ariz. In the Motion, Attorney Engle indicates that Deputy Public Defender Dawnese Hustad intends to proceed as lead counsel.
- The Court observes that the Maricopa County Public Defender's Office was appointed to represent Appellant Jasper Phillip Rushing in this matter, and Attorney Engle has entered an appearance as lead counsel and Attorney Hustad has entered an appearance as co-counsel.
- Based on the foregoing,
- IT IS ORDERED that the Public Defender's Office file forthwith an amended notice of appearance that confirms Deputy Public Defender Hustad's change of assignment, as indicated in the Motion, from co-counsel to lead counsel.
- IT IS FURTHER ORDERED that the amended notice of appearance filed by the Public Defender's Office shall confirm that Attorney Engle is leaving the Public Defender's Office and is no longer, as of a specific date, assigned as lead counsel for Appellant by the Public Defender's Office.
- As observed in the Motion, to allow for uninterrupted representation and assist in the prompt filing of Appellant's Opening Brief,
- THE COURT FINDS that Attorney Engle's request that the Office of Public Defense Services ("OPDS") seek her appointment by the Maricopa County Superior Court as co-counsel in this matter is reasonable to the extent Attorney Engle meets the requirements for appointment as co-counsel pursuant to Ariz. R. Crim. P. 6.8(a), (c), and, if necessary, Ariz. R. Crim. P. 6.8(e).
- Therefore,
- IT IS ORDERED pursuant to Ariz. R. Crim. P. 31.5(e) that upon request by the Maricopa County Public Defender's Office that the Office of Public Defense Services seek appointment of Attorney Engle to represent Appellant in these proceedings, the Maricopa County Superior Court may appoint Attorney Engle, upon confirmation and finding that Attorney Engle meets the requirements of Ariz. R. Crim. P. 6.8(a) and (c), and if necessary Ariz. R. Crim. P. 6.8(e), as co-counsel to represent Appellant in these proceedings and inform the Court of the appointment.
