IT IS ORDERED that Petitioner's Motion to Exceed Word Count is denied in part and granted in part.

IT IS FURTHER ORDERED that Petitioner's Petition for Review of Summary Dismissal of Post-Conviction Relief in Death Penalty Case filed August 10, 2023, is stricken.

IT IS FURTHER ORDERED that on or before September 12, 2023, Petitioner shall file a petition for review that shall not exceed 20,000 words, and shall otherwise comply with Ariz. R. Crim. P. 32.16(c)(1) and (c)(2). No extensions of this due date shall be granted absent extraordinary circumstances. (Kathryn H. King)

After Petitioner had submitted a Petition for Review containing 51,072 words, on August 11, 2023, this Court ordered that on or before September 12, 2023, Petitioner was allowed to file a Petition for Review not exceeding 20,000 words, and shall otherwise comply with Ariz. R. Crim. P. 32.16(c)(1) and (c)(2). Petitioner requested extensions of ten days and seven days, which this Court granted.

Petitioner's third motion for extension of time, like his prior requests, states that more time is needed for counsel to read, review and discuss the amended petition for review with Petitioner Moore. The motion further states that counsel and Petitioner have "completed reading/review of 55.3% of the new draft of his Petition for Review." The State has previously objected to further extensions of time in this matter. The motion requests an extension to October 6, 2023.

IT IS ORDERED granting an extension of time to and including October 6, 2023, to file the Petition for Review. Counsel is admonished that repeated motions for extensions of time are disfavored, and that counsel is responsible for accurately calculating the additional time necessary to complete the pleading. Therefore, any additional motions for extension of time are unlikely to be granted. (Hon. Clint Bolick)

Moffitt*, 417 U.S. 600, 617-19 (1974).
- Moreover, the Court notes that any new counsel in this appellate proceeding is likely to encounter the same strategy conflict Moore is alleging, as the claims Moore wants new counsel to raise, which fall within counsel's responsibility, are subject to waiver. See *State v. LaGrand*, 152 Ariz. 483, 486 (1987) ("whether new counsel would be confronted with the same conflict" relevant to whether new counsel should be appointed); *State v. Lopez*, 217 Ariz. 433, 438 ¶ 17 n.4 (App. 2008) ("Generally, issues raised for the first time in a reply brief are waived."); cf. *State v. Herrera*, 183 Ariz. 642, 647 (App. 1995) ("appellate counsel is responsible for evaluating the trial record and for determining the most promising issues to present").
- It also appears that communication is still occurring, and counsel has avowed that a meeting to review the response and reply is set to soon take place, which addresses the other concern identified in Moore's notice and supports a brief, further extension in this voluminous capital matter. Based on the foregoing,
