7. 29-Apr-2024 On April 29, 2024, Petitioner Qureshi filed a third Motion for Procedural Order for Extension of Time to File Petition for Review. Petitioner requests a 90-day extension of time to file the petition for review due to an ongoing petition in the court of appeals in a companion case. Petitioner requests, “[i]n the interest of judicial economy,” that this Court extend the due date for his petition for review in this matter until the court of appeals has reviewed and decided his petition for review before that court in 1 CA-CR 24-0110 PRPC.
- Petitioner advises that he has pending post-conviction relief matters in the superior court in two different matters: namely, CR2013-427046-001 and CR2014-001042-001. The court of appeals consolidated Petitioner’s appeals on the two matters. See State v. Qureshi, 1 CA-CR 19-0536, 1 CA-CR 19-0537, 2020 WL 6495078, at \*2, ¶ 10 (Ariz. App. Nov. 5, 2020) (mem. decision).
- Petitioner’s instant motion states that he filed a pro per petition for post-conviction relief listing both case numbers, however, the superior court’s initial ruling denying post-conviction relief only addressed the 2013 matter — leading to the petition for review in the court of appeals noted in the caption. He further states that after addressing the missing ruling with the superior court on his petition for post-conviction relief related to the 2014 case, the superior court issued a ruling and Petitioner filed a petition for review (1 CA-CR 24-0110 PRPC) in the court of appeals.
- Therefore, upon consideration and good cause appearing, and on the Court’s own motion in the interest of judicial economy and efficiency,
- Petitioner’s Motion for Procedural Order for Extension of Time to File Petition for Review is granted to the extent that, pursuant to Rules 32.16(f)(1)(B) and 32.16(g) and the Court’s authority pursuant to Rules 31.3(a) and (e),
- IT IS ORDERED staying this matter pending the court of appeals’ ruling on Petitioner’s petition for review in 1 CA-CR 24-0110 PRPC.
- IT IS FURTHER ORDERED that Petitioner shall file regular status reports with this Court every 30 days advising the Court of the status of proceedings in the court of appeals on Petitioner’s petition for review in 1 CA-CR 24-0110 PRPC.
- IT IS FURTHER ORDERED that Petitioner shall notify this Court of the court of appeals’ final ruling not later than 10 days after the court’s final decision on Petitioner’s petition for review in 1 CA-CR 24-0110 PRPC.
- IT IS FURTHER ORDERED that upon the filing of the court of appeals’ final ruling in 1 CA-CR 24-0110 PRPC, any petition or cross-petition for review to this Court shall be filed in compliance with Ariz. R. Crim. P. 32.16(a), (c)(1) and (c)(2).
- Upon filing of Petitioner’s petition for review in this Court in this matter and from 1 CA-CR 24-0110 PRPC, the Court will entertain a motion to consolidate the matters. (Hon. John R Lopez IV)
