9. 14-Jun-2024 On June 7, 2024, the due date for filing the petition for review in this matter, Appellants filed their third motion to extend the petition for review filing deadline. Appellee objects to the extension, arguing that the appellants have engaged in a pattern of delay throughout the proceedings and that their claimed basis for the third extension is otherwise identical to the basis of their second extension request. Having reviewed the record and pleadings in this matter,
- IT IS ORDERED granting an extension of 14 days from the date of this order to file the petition for review. No further extensions will be granted. The matter will be dismissed if the petition for review is not filed on or before June 28, 2024. (Hon James P Beene)

- The Court of Appeals issued its memorandum decision on February 6, 2024.
