On June 20, 2024, on its own motion, the Court, in CR-13-0282-AP ordered that it would consider the issue presented by Petitioner Mayes' State of Arizona's Motion to Strike Nonparty Maricopa County Attorney's Motion to Set Briefing Schedule for Motion for Warrant of Execution filed in response to Respondent Mitchell's Motion to Set Briefing Schedule for Motion for Warrant of Execution as a separate standalone petition for special action relief.

In that same order, the Court further stated that in this special action it would consider:

Whether the constitutional and statutory authority, power, and duty to request a warrant of execution pursuant to A.R.S. § 13-759(A) and Ariz. R. Crim. P. 31.23(a) and (b) rests exclusively with the Arizona Attorney General.

Therefore,

IT IS ORDERED that Petitioner Mayes and Respondent Mitchell file simultaneous supplemental briefs on or before July 22, 2024, not to exceed 5,000 words. Real Party in Interest Gunches may file a simultaneous brief addressing the above issue on or before July 22, 2024, not to exceed 5,000 words.

IT IS FURTHER ORDERED that any amicus curiae may file briefs pursuant to ARCAP 16 and in accordance with ARCAP 16(d)(2) on or before August 5, 2024.

IT IS FURTHER ORDERED that Petitioner and Respondent may file omnibus responses to any briefs of amicus curiae not to exceed 5,000 words on or before August 19, 2024.

IT IS FURTHER ORDERED that, although A.R.S. § 12-1841 does not explicitly apply to the issue before the Court in this matter, counsel for the Arizona Attorney General shall notify the Speaker of the House of Representative and the President of the Senate of this matter by serving copies of the pending pleadings and this order within five court days of this order and shall file an appropriate certificate of service with the Court. 12. 23-Jul-2024 On July 22, 2024, pro per David Redkey filed a "Brief of Amici [sic] Curiae of David Redkey" and "Motion for Permission to File as Amicus."

This Court denied the "Motion for Permission to File as Amicus" and ordered that the "Brief of Amici [sic] Curiae of David Redkey" be stricken from the record in an order dated July 22, 2024.

On July 22, 2024, Mr. Redkey filed a "Motion to Suspend Rules to Amend Motion for Permission to File an Amicus Curiae Brief," to allow him "to address an unintentional exclusion and to ensure comprehensive representation of the interests at stake, which directly affect Mr. Redkey and the integrity of judicial proceedings."

The Court was clear in its July 22, 2024 order that Mr. Redkey and the positions presented in his amicus brief do not meet the requirements of ARCAP 16(b)(1)(C).

Therefore,

IT IS ORDERED denying Mr. Redkey's "Motion to Suspend Rules to Amend Motion for Permission to File an Amicus Curiae Brief.
