The joint motion specifically sought an extension until August 26, 2024, for Appellees Cochise County to file the petition for review. The joint motion further noted that Appellants' anticipated cross-petition for review would be due 15 days after the filing of the petition for review.
- On July 18, 2024, the parties filed a second joint motion for an extension. This motion seeks an extension of time for Appellants to file a petition for review, specifically until August 26, 2024. Pursuant to Arizona Rules of Civil Appellate Procedure 23(b)(2)(C), a party may file a cross-petition for review within 15 days after service of a petition for review.
- Based on the foregoing, Appellants' cross-petition for review will not be due until 15 days after service of Cochise County's petition for review. By virtue of extending the deadline for Cochise County to file the petition for review, the deadline for Appellants' cross-petition for review has already been extended. Accordingly,
