- 7-Aug-2024 The Court of Appeals issued its Memorandum Decision on June 27, 2024 affirming the trial court and awarding Appellees Grant, et al., a portion of their reasonable attorney's fees on appeal. On June 28, 2024, Appellant Danko, pro se, filed a "Motion for Relief from Judgment Dated 6/27/2024," which the Court of Appeals denied on July 10, 2024. On July 31, 2024, the Court of Appeals entered an order awarding Appellees \$4,000.00 for attorney's fees and \$350.31 for costs. After requesting and receiving an extension of time to file a petition for review, on August 6, 2024, Appellant Danko filed a timely petition for review of the June 24, 2024 memorandum decision and the July 10, 2024 order. Appellant then filed a motion seeking an extension of time to file a petition for review to challenge the July 31, 2024 Court of Appeals award of fees and costs. Upon consideration,
IT IS ORDERED denying the request for extension of time to file a separate petition for review of the July 31, 2024 order without prejudice to filing an amended petition for review challenging all three Court of Appeals decisions issued in July 2024.
IT IS FURTHER ORDERED any amended petition for review shall be filed not later than August 28, 2024. (Hon William G Montgomery)
