# PAUL FAHRING v STATE OF ARIZONA

#### **5 PROCEEDING ENTRIES**

1-Aug-2024

On May 30, 2024, Petitioner Paul Fahring, Pro se, filed a "Notice of Failure to Complete a Legal Duty" alleging that he has not received copies of various minute entries and rulings filed in Pinal County Superior Court in this matter, including the court's ruling dismissing his petition for post-conviction relief filed pursuant to Ariz. R. Crim. P. 33. Subsequently, Petitioner filed a "Motion for Emergency Injunction" on July 3, 2024, and a document titled "Update Notice" on July 17, 2024.

On June 14, 2024, the superior court issued a minute entry, stating that:

The Court has received and reviewed Defendant, Paul Fahring's, Request for Extension of Time to File Petition for Review (Court of Appeals) filed on June 4, 2024, and Motion for Clarification filed on June 7, 2024.

As to Defendant's Motion for Clarification, the Court FINDS that on May 15, 2024, a ruling was drafted and on May 16, 2024, the ruling was placed for Judge's review. On May 20, 2024, the ruling was electronically signed and issued by the Clerk of the Court and a copy was mailed to Defendant Fahring.

IT IS HEREBY ORDERED granting the request for extension of time up to August 15, 2024, to file his petition for review with the Court of Appeals and denying the request for clarification.

The superior court further ordered the Pinal County Clerk of Court "to attach a copy of the ruling issued on May 20, 2024, Denying the Petition for Post-Conviction Relief" to the June 14, 2024 minute entry when mailing it to Petitioner. Upon consideration,

THE COURT FINDS that Petitioner's "Update Notice" makes no specific request for relief. Therefore,

IT IS ORDERED that the "Update Notice" is dismissed as moot.

Furthermore, to ensure that Petitioner has received the superior court's rulings, including the ruling denying Petitioner's initial Rule 33 petition for post-conviction relief,

IT IS FURTHER ORDERED that the Pinal County Clerk of Court, Rebecca Padilla, shall file with this Court forthwith a notice of filing that includes as attachments all minute entries, orders, and rulings filed in the Pinal County Superior Court in this matter from November 1, 2023 to date ("Notice of Filing with Attachments"). The Pinal County Clerk of Court shall also include a certificate of service affirming that the Notice of Filing with Attachments was sent to (1) the Petitioner, and (2) the Arizona Department of Corrections, Rehabilitation, and Reentry's General Counsel, Ashley Oddo.

IT IS FURTHER ORDERED that the Arizona Department of Corrections, Rehabilitation, and Reentry shall separately provide a copy of this order and the Notice of Filing with Attachments to Petitioner. Such delivery shall occur forthwith upon General Counsel Ashley Oddo's receipt of the Notice of Filing with Attachments. After such delivery, the Arizona Department of Corrections, Rehabilitation, and Reentry shall forthwith file a certificate of service in this Court affirming its delivery of this order and the Notice of Filing with Attachments to Petitioner.

IT IS FURTHER ORDERED extending the due date for Petitioner to file a petition for review from the superior court's denial of his petition for post-conviction relief in the court of appeals until thirty days after the date that the Arizona Department of Corrections, Rehabilitation, and Reentry's certificate of service indicates that it delivered this order and the Notice of Filing with Attachments to Petitioner.

IT IS FURTHER ORDERED that Petitioner's "Notice of Failure to Complete a Legal Duty" is denied as moot.

IT IS FURTHER ORDERED that Petitioner's "Motion for Emergency Injunction," other than as ordered herein, is denied as moot.

IT IS FURTHER ORDERED that the Clerk of Court shall close this case (M-24-0021) following receipt of each of the documents and certificates of service ordered herein. (Hon. Kathryn H. King)
