2. 5-Dec-2022 On December 1, 2022, Kathleen E. Brody and Jared G. Keenan of the Arizona Attorneys for Criminal Justice ("AACJ") filed a rule petition on AACJ's behalf proposing to abrogate Rules 39(b)(1)(A) and (B) of the Rules of Criminal Procedure. The petition further requests that: (a) the petition be given expedited consideration under Rule 28(h)(1), Rules of the Supreme Court of Arizona; and (b) its proposed abrogation of Rules 39(b)(1)(A) and (B) be adopted on an emergency basis under Rule 28(h)(2) of the same rules.
- Upon consideration by the Court,
- IT IS ORDERED denying the request for expedited consideration.
- IT IS FURTHER ORDERED denying the request to abrogate Rules 39(b)(1)(A) and (B) of the Rules of Criminal Procedure on an emergency basis.
- IT IS FURTHER ORDERED that the petition shall be opened for public comment this January under Rule 28(c) of the Rules of the Supreme Court of Arizona and will be considered by the Court during its August 2023 Rules Agenda. (Hon. Robert Brutinel)
3. 17-Jan-2023 Rule petitions have been filed in the above-captioned matters under Rule 28(a), Rules of the Supreme Court of Arizona. Upon consideration,
- IT IS ORDERED that these petitions are opened for public comment pursuant to Rule 28(c), Rules of the Supreme Court of Arizona. Comments must be submitted no later than Monday, May 1, 2023, and any reply by a petitioner must be submitted no later than Thursday, June 1, 2023.
