- 20-Aug-2024 WOULD AMEND RULES 34, 38, AND 39 OF THE RULES OF THE SUPREME COURT OF ARIZONA TO CLARIFY THE PHRASES "GOOD STANDING" AND "ACTIVE PRACTICE OF LAW," AND TO SIMPLIFY RULE 34'S BAR APPLICATION REQUIREMENTS

ORDERED: Petition to Amend Rules 34, 38, & 39 Rules of the Supreme Court of Arizona = ADOPTED with respect to the proposed amendments to Rules 34(b), (d),(e), (h), and (n), and the proposed amendments to Rules 38 and 39, effective January 1, 2025.

FURTHER ORDERED: Consideration of the proposed amendment to Rule 34(f) continued until the August 2025 Rules Agenda.

IT IS ORDERED that Rules 34, 38, and 39 of the Rules of the Supreme Court of Arizona are amended in accordance with the attachment to this order, effective January 1, 2025.

IT IS FURTHER ORDERED that the Court's consideration of the petition's proposed amendments to Rule 34(f) of the same rules is continued until the August 2025 Rules Agenda, pending the Court's consideration of the proposed amendments to Rule 34(f) set forth in Rule Petition R-24-0028.
