In August 2023, this Court established the Task Force on the Rules of Procedure for Special Actions ("the Task Force") to revise and restyle the special action rules. On December 13, 2024, Mark Meltzer, a Task Force staff member, filed a motion on the Task Force's behalf. The motion indicates that the Task Force is making progress in preparing a set of proposed rule revisions for the Court's consideration. It also says, however, that the Task Force does not anticipate that it will be able to file a rule petition with the Court by January 10, 2024, which is the deadline set forth in Rule 28(a)(2), Rules of the Supreme Court of Arizona, if the Court is to consider the petition during the August 2024 Rules Agenda.

Consequently, the motion asks the Court to enter an order suspending the portion of Rule 28(a)(2) imposing a January 10, 2024, filing deadline and providing that the Court will consider the Task Force petition during the August 2024 Rules Agenda if it is filed no later than February 23, 2024. The motion also proposes that when the Court opens the petition for public comment, it imposes a deadline of May 17, 2024, for submitting public comments and a deadline of June 21, 2024, for submitting any Task Force reply.

After considering the motion and finding good cause for suspending part of Rule 28(a)(2) under Rule 28(i), Rules of the Supreme Court of Arizona,

IT IS ORDERED suspending Rule 28(a) of the Rules of the Supreme Court of Arizona to the extent it provides that this Court may consider a petition by the Task Force during the August 2024 Rules Agenda only if it is filed by January 10, 2024.

IT IS FURTHER ORDERED that the Court will consider the Task Force's petition to revise and restyle the Rules of Procedure for Special Actions during the August 2024 Rules Agenda if it is filed no later than February 23, 2024.

IT IS FURTHER ORDERED that if the Task Force's petition is filed by no later than February 23, 2024, the Court will open the petition for public comment, with all comments due no later than May 17, 2024, and any reply by the Task Force due no later than June 21, 2024. (Hon. Robert Brutinel)

## **RULES OF PROCEDURE FOR SPECIAL ACTIONS**

### 17 PROCEEDING ENTRIES

In August 2023, this Court established the Task Force on the Rules of Procedure for Special Actions ("the Task Force") to revise and restyle the special action rules. On December 26, 2023, the Court entered an order granting a motion by the Task Force to suspend Rule 28(a)(2) of the Rules of Supreme Court of Arizona, which says a rule petition must be filed by January 10 in order for it to be considered by the Court during its Rules Agenda the following August. The order further provided that if the Task Force filed its rule petition regarding the special action rules by February 23, 2024, the Court would consider the petition during its

August 2024 Rule Agenda and open the petition for public comment.

On February 22, 2024, the Task Force filed its rule petition with the Court. Accordingly, consistent with the Court's December 26, 2023 order,

IT IS ORDERED that the Court will consider the Task Force's petition during its August 2024 Rules Agenda.

IT IS FURTHER ORDERED that this petition is opened for public comment under Rule 28(c), Rules of the Supreme Court of Arizona, with all comments due no later than May 17, 2024, and any reply by the Task Force due no later than June 21, 2024.

### 17 PROCEEDING ENTRIES

A petition having been filed proposing to abrogate and replace the current Rules of Procedure for Special Actions with a new set of rules, and the Court having considered the petition, comments, and reply,

IT IS ORDERED that the current Rules of Procedure for Special Actions and their associated comments are hereby abrogated, effective January 1, 2025.

IT IS FURTHER ORDERED that the Rules of Procedure for Special Actions and their associated comments and forms, as shown in Attachment A, are hereby adopted, effective January 1, 2025.

IT IS FURTHER ORDERED that the newly adopted rules shall apply:

(1)in all special actions filed on or after January 1, 2025; and

(2)in all other special actions pending on January 1, 2025, except to the extent that the court in an affected special action determines that applying a newly adopted rule would be infeasible or work an injustice, in which event the former rule of procedure applies.

IT IS FURTHER ORDERED that the Table of Contents and Correlation Table shown in Attachment B are hereby approved for publication and shall appear before the beginning of the newly adopted rules shown in Attachment A, with the Correlation Table following the Table of Contents.

IT IS FURTHER ORDERED that Rule 1.9(v)(2) of the Rules of Criminal Procedure and the comment following Rule 10 of the Arizona Rules of Civil Appellate Procedure are hereby amended as is shown in Attachment C to this order, effective January 1, 2025. (Hon. Ann A. Scott Timmer)
