9. 3-Jan-2024 On November 6, 2023, the Hearing Panel entered its Decision and Order finding that Respondent violated two ethical rules by making certain representations to the Bar and the Hearing Panel, but found that the Bar did not prove by clear and convincing evidence that Respondent violated ethical duties as alleged in Count I or Count II of the Bar's original complaint. The Panel imposed a sanction of suspension. Respondent sought a stay of the sanction, which the Panel denied, finding that Respondent had not met his burden of proof required for the requested stay. The Panel also agreed with the State Bar that the record in the case demonstrated there were no appropriate conditions of supervision sufficient to protect the public.
- On December 8, 2023, the Court received Respondent's "Special Action with Request for Stay," which the Court has filed in Respondent's appeal. Respondent argues that the Hearing Panel abused its discretion in denying Respondent's request for a stay of his suspension while an appeal is pending. Respondent requests that the Court stay the sanction imposed by Hearing Panel until thirty days after the Court's ruling on the appeal. On December 19, 2023, the State Bar filed a "Response to Petition for Special Action and Request for Stay." The State Bar asserts that Respondent failed to satisfy the elements required to warrant a stay and specifically failed to establish a likelihood of success on the merits. On December 29, 2023, Respondent filed a reply.
- Upon consideration, the Court finds that Respondent did not in his request for stay before the Acting Presiding Disciplinary Judge or in this Court sufficiently address the elements of a stay. However, Rule 59(c) provides that an "application for stay pending appeal shall be granted subject to appropriate conditions of supervision, except when an interim suspension has been ordered or when the hearing panel, in its discretion, determines that no conditions of supervision will protect the public while the appeal is pending." (Emphasis added.) In this case, the discipline imposed was not based on Respondent's representation of clients but his statements made during the disciplinary proceedings. Under those circumstances, it is not clear that the public needs protection. Therefore, the Panel erred in denying the request for stay.
- IT IS ORDERED that the request for stay of the Hearing Panel's November 6, 2023 Decision and Order Imposing Sanctions is granted pending resolution of Respondent's appeal. The suspension is stayed without conditions and without prejudice to the State Bar seeking a modification of the stay and submitting proposed recommendations for conditions it believes to be reasonable based on the found ethical violations.
