5. 1-Jul-2026 Applicant Sierra Murdock submitted a Verified Petition for Review, Motion for Leave to File Verified Petition for Review Out of Time, and Motion to Seal on June 24, 2026 for the July 2026 writing of the UBE—the administration of which is only one month away. Applicant requests additional accommodations.

Applicant concedes that the Petition for Review was filed more than 20 days after the Committee's denial. Although Applicant acknowledges that she received an Independent Review Report from the Committee, she did not submit the Report to the Court. It also appears she did not submit a Form 2 to the Committee until March 21, 2026, which may have implicated the April 30 deadline, if additional information was needed. See Administrative Order 2024-078, "Close of Filing for applications and supporting documentation, including accommodation requests."

Preparation for the July 2026 UBE is underway. Due to the lack of information and the late request, the Court cannot conclude that Applicant has established that she is entitled to relief or whether it can be granted at this late stage of preparation. Upon consideration of the Court, en banc,

IT IS ORDERED granting the Motion for Leave to File Verified Petition for Review Out of Time.

IT IS ORDERED denying the Verified Petition for Review.

IT IS FURTHER ORDERED granting the Motion to Seal and restricting from the public access to all records associated with this matter. (Hon. Ann A. Scott Timmer)
